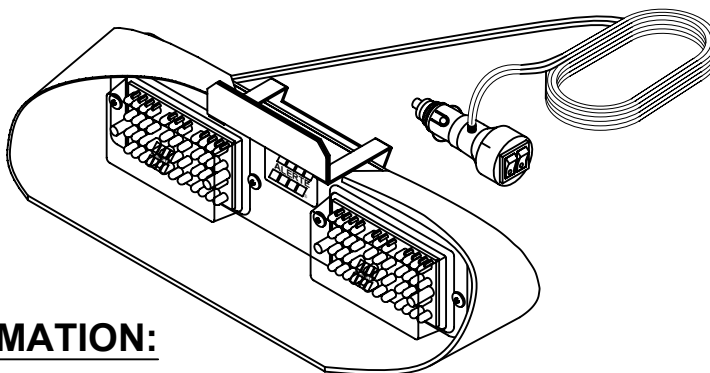

GENERAL INFORMATION:

Two super bright LED arrays, 44 LED's per side. There are other array combinations to suit your jurisdiction or ordinance requirements from RED, BLUE, AMBER, GREEN or WHITE LED's. Each array equipped with vertical rows of white LEDs at their outer edges to provide the "halo" effect pioneered by ALERTE to enhance visibility.

Seven flash patterns to choose from:

1. 90 Single FPM Simultaneous
2. 90 Double FPM Simultaneous
3. 70 Quad FPM Simultaneous
4. 120 Alternating FPM
5. Automatic Alternating Variable Speed
6. Automatic Simultaneous Variable Speed
7. Automatic Random Select

To change flash pattern, press the momentary switch (Located on the lighter plug adapter). Each time the momentary switch is pressed, the flash pattern will change.

INSTALLATION INSTRUCTIONS:

*If the "Mark 12" is equipped with an anti-flashback shield, it can be trimmed to more closely match the slope of the glass surface against which it is mounted.

The "Mark 12" is a self contained light system equipped with LED arrays that can be mounted in any of several locations within a vehicle.

After choosing a location for the "Mark 12", bend the mounting bracket, if necessary, to insure that the unit will hang vertically. Carefully clean the selected glass location with an alcohol swab.

CAUTION: The adhesive backed tape used to secure the light is a very aggressive contact tape that is virtually impossible to remove or relocate.

Once you have carefully chosen a location, remove the film from the foam tape adhered to the mounting bracket. Place the bottom edge of the foam tape against the chosen spot, tilt the bracket upward to adhere the tape to the glass, and apply pressure to the back of the foam tape portion of the bracket to secure it and to remove any trapped air.

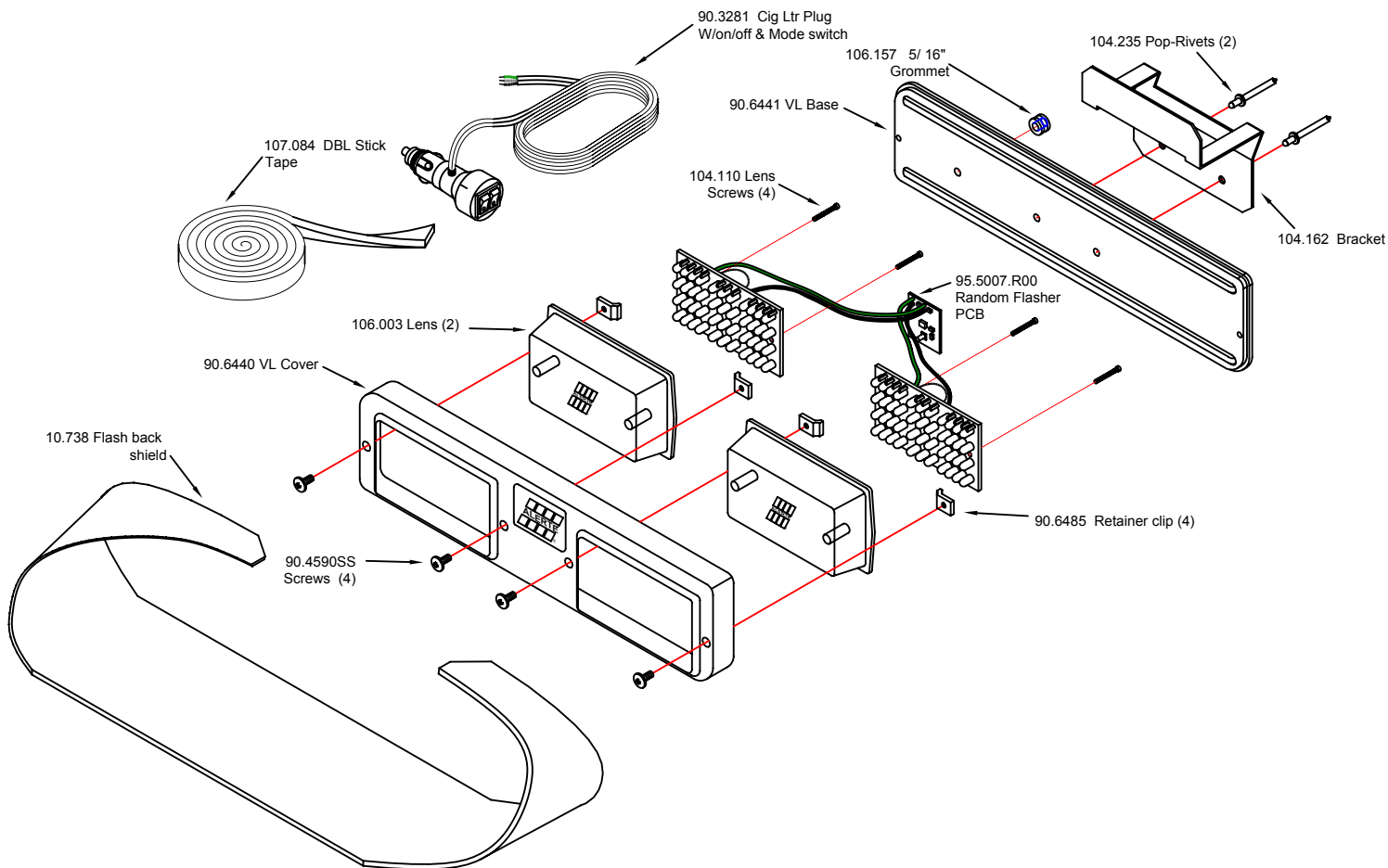
